

## Warranty Information

The Vollrath Company LLC warrants each of its products listed below against defects in materials and workmanship for the applicable period provided below. All other products manufactured or distributed by The Vollrath Company LLC are warranted against defects in materials and workmanship for a period of one year. In all cases, the warranty runs from date of the end user's original purchase found on the receipt.

**THIS WARRANTY DOES NOT APPLY TO PRODUCTS PURCHASED FOR PERSONAL, FAMILY OR HOUSEHOLD USES AND THE VOLLRATH COMPANY LLC DOES NOT OFFER A WRITTEN WARRANTY TO PURCHASERS FOR SUCH USES.**

No remedy will be available for products that have been damaged by accident, carelessness, improper installation, lack of proper setup or supervision (when required), neglect, improper use, installation or operation contrary to installation and operating instructions, normal wear and tear (such as knife scoring on cutting boards), or other causes not arising from defects in materials or workmanship.

- Refrigeration compressors – The warranty period is 5 years. The warranty is for parts only. Service is not included.
- Marine Grade Hot Well Drop-ins – The warranty period is 2 years.
- Refrigerated Display Cases (RDE) compressors the warranty is 3 years.
- Cayenne® Heat Strips, heating element only – The warranty period is 2 years. The second year of the warranty is for parts only. Service is not included.
- Ultra, Ultra Fajita, Mirage® Pro and Professional Induction Ranges – The warranty period is 2 years.
- ServeWell® Induction Workstation, induction hobs only – The warranty period is 2 years.
- V-Class Custom – The warranty period is 2 years.
- Slicers gears – The warranty period is 10 years.
- Slicers belts – The warranty period is 5 years.
- Slicers – No remedy will be available for slicers where blade has not been sharpened. (Refer to owner's manual for sharpening instructions.)
- Mixers – The warranty period is 2 years, The second year of the warranty is for parts only. Service is not included.
- Mixer belts - The warranty period is 5 years.
- Mixers – No remedy will be available for mixers damaged by changing gears while unit is running or overloading, as determined by a Vollrath Certified Technician.
- In-Chamber Vacuum Packing Machines – The warranty period is one year on the pump, 2 years on other warranty parts.
- Manual Food Processors – The warranty period is 2 years.
- Toasters – JT1, JT1H, JT1B, JT1BH Toasters- Repair for these products is available via carry-in service. The warranty period on warranted parts is 2 years on parts, 1 year labor. The warranty period for heater tubes is 1 year, including labor when performed at an authorized service center - glass damage is not covered by this warranty. All Other Toasters - The warranty period on warranted parts is 2 years on parts, 1 year labor. The warranty period for heater tubes is 1 year, including labor - glass damage is not covered by this warranty.
- Conveyor Ovens - The warranty period on warranted parts is 2 years on parts, 1 year labor. The warranty period for heater tubes is 1 year, including labor - glass damage is not covered by this warranty
- Cheese Melters – JW1 and JW2 Cheese Melters - Repair for these products is available via carry-in service. The warranty period on warranted parts is 2 years on parts, 1 year labor. The warranty period for heater tubes is 1 year including labor when performed at an authorized service center - glass damage is not covered by this warranty. All Other Cheese Melters - The warranty period on warranted parts is 2 years on parts, 1 year labor. The warranty period for heater tubes is 1 year, including labor center - glass damage is not covered by this warranty.
- Frozen Beverage Granita Machines – The warranty period is 2 years on warranty parts, 3 years on the electronic board, 5 years the compressor. Warranty is for parts only, service is not included.

- Food Delivery Bags and liners – The warranty period is 30 days.
- Heat Pads, Power Packs, Power Cords and Power Pack Chargers for use with Food Delivery Bags – The warranty period is 90 days.
- EverTite™ Riveting System, loose rivets only. The warranty period is lifetime for the original purchaser.
- Optio/Arkadia product lines – The warranty period is 90 days.
- Non-stick surfaces are warranted for 90 days.
- TRAX® Non-Skid Round Trays have a lifetime warranty.
- Replacement parts – The warranty period is 90 days.
