Coverage for customers outside of the USA and Canada will be for parts only.

Determination of repair or replacement will be at the sole discretion of Winco.

EXCLUSIONS: Light bulbs, blades or coatings are not covered under said warranty. The labor warranty is one (1) year from original purchase date from dealer, or 18 months from Winco shipment date, whichever date occurs first.

WINCO'S OBLIGATION AND LIABILITY UNDER THIS WARRANTY IS EXPRESSLY LIMITED TO REPAIRING AND REPLACING EQUIPMENT THAT PROVES TO BE DEFECTIVE IN MATERIAL OR WORKMANSHIP, WITHIN THE APPLICABLE WARRANTY PERIOD.
